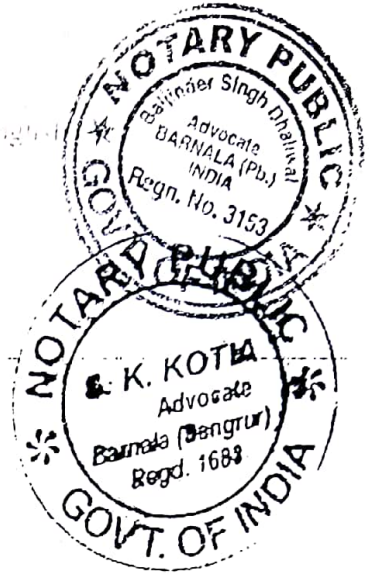

Punjab, Chandigarh and considering upon them the No Objection Certificate by Punjab Government is issued on the following conditions:-

That if in future, on any complaint/inspection, it is found that you have submitted application with Punjab Government based on wrong information for getting no objection certificate and or you are not abiding by the instructions issued by Punjab Government from time to time and you are not following the conditions mentioned in the affidavit then in this case the no objection certificate issued to you can be withdrawn at any time.

That it will be compulsory to teach Punjabi upto tenth level in yours school and C.B.S.C. New Delhi will make it compulsory to hold examination of Punjabi in such schools and further it is categorically stated in case of not so doing the no objection certificate will be withdrawn immediately.



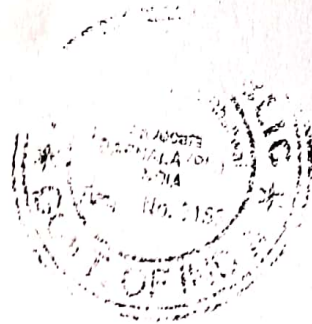

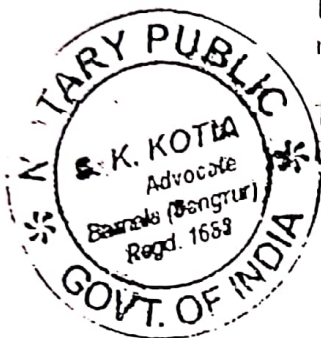

That you yourself and your management will make it possible that if at any time the District Education Officer of your district or any senior official of Education Department demands any type of information then he will be provided with necessary information and required assistance will also be given to him.
