Provided, further that in case of pre primary classes also, this norm shall be followed.

For the children referred to in paragraph 3, the School shall be reimbursed as 4. per Section 12(2) of the Act. To receive such reimbursements school shall

provide a separate bank account.

The Society/School shall not collect any capitation fee and subject the child or 5. his or her parents or guardians to any screening procedure.

The School shall not deny admission

To any child for lack of age proof.

If such admission is sought subsequent to the extended provided prescribed for admission.

On the ground of religion, caste or race, place of birth or any of them.

The School shall ensure: 7.

- No child admitted shall be held back in any class or expelled from (i) school till the completion of elementary education in a school;
- No child shall be subjected to physical punishment or mental (ii) harassment;
- No child is required to pass any board examination till the (iii) completion of elementary education;
- Every child completing elementary education shall be awarded a (iv) certificate as laid down under Rule 23
- Inclusion of Students with disabilities/special needs as per provision (V)
- The teachers are recruited with minimum qualifications as laid (vi) under section 23(1) of the Act. Provided further that the current

teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;

The teacher performs its duties specified under section 24(1) of the (vii)

The teachers shall not engage himself or herself for private teaching (viii)

The School shall follow the syllabus on the basis of curriculum laid down by 8.

The School shall enroll students proportionate to the facilities available in the 9.

School as prescribed in the section 19 of the Act.
