(vii) The teacher performs its duties specified under section 24(1) of the

Act and

(viii) The teachers shall not engage himself or herself for private teaching activities.

 The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

 The School shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
